With reference to our discussion on 24 April 2023 at our office Bhopal, we are pleased to offer you the position of Assistant Manager (Media & Communication) in Consortium of Small Farmers Agriculture & Livelihoods (cSfal) which is a not for profit making Company and development wings of Madhyabharat Consortium of Farmers Producer Company Ltd, Bhopal and Head Quartered at Bhopal, Madhya Pradesh. This appointment will commence from the date on which you join the Company. Your appointment will be governed by the following terms and conditions:-

- a. You will be entitled for remuneration as per Annexure 1, subject to statutory deductions. The achievement of minimum output fixed from time to time is a pre-condition for the entitlement of the above remuneration.
- b. You shall be eligible for a fix remuneration of INR 18000/ (Eighteen thousand only) per
- c. You will be in probation period and time of your probation period shall be varies from 6-12 months and after successfully completion of your probation you can be eligible for some increment or other benefits as per the norms of the organization.
- d. You shall be entitled to reimbursement of travel and logistics expenses during outside the head quarter travel related to official work as per the rate fixed by the company for you or prevailing travel rules of the Company which shall be informed you during joining to the company.
- e. This is a contractual & renewable job and the period of contract shall be initially 5 for years from the date of joining which can be renewed again on the completion of said period however the renewable will completely depend upon your performance and opportunities in the Company.
- f. In case of any kinds of in disciplinary act/ dishonesty/ poor performance, lack of integrity towards organization or negligence towards worked assigned to you, this contract can be terminated by serving a short notice of 3-7 days.
